## Notice of Resolution to amend MPGA By-laws

Dear MPGA Member,

The Manitoba Pulse Growers Association (MPGA) Board of Directors is recommending the attached amended by-laws be presented to the membership for consideration at the Annual General Meeting scheduled for February 8, 2012 at 8:30 a.m. at the Victoria Inn Hotel and Convention Centre.

The current constitution and bylaws were last amended in 2004. Since then, the association has grown and changed and amending the bylaws is deemed appropriate. The following amendments are being brought forward to the membership:

#### Amendment #1 to By-law (3): OBJECT

• The object of the association has been updated to incorporate what the association currently does for its members, but will not limit the association in its ability to accomplish its goals. Previous points d), e) and g) have been removed. Additional tasks completed by the association can be incorporated in e) which states: "Using such other means as may, from time to time, seem desirable."

#### Amendment #2 to By-law (4): MEMBERSHIP

- Associate and Patron Memberships have been removed from the bylaws. The board feels these 2 memberships can be encompassed under Honorary Members as the board sees fit.
- In addition, the Membership Fees for Associate and Patron members have been removed.

#### Amendment #3 to By-law (6): MEETINGS

• The maximum days notice given to members regarding the annual general meeting or a special meeting has been increased to 75 days. This date now coincides with the publication schedule of our winter issue of *Pulse Beat* therefore no additional notice of meetings is required.

## Amendment #4 to By-law (8 & 13): BOARD OF DIRECTORS

 The following appointed directors have been changed to Advisory Directors with no voting abilities, due to possible conflict of interest relating to project funding: Manitoba Agriculture, Food and Rural Initiatives representative, Faculty of Agriculture and Food Sciences, University of Manitoba representative and Agriculture and Agri-Food Canada representative.

- The representative nominated from the Canadian Special Crops Association voting abilities will be at the instruction of his or her employer.
- A tie vote at the board table will be considered a defeated motion.

## Amendment #5 to By-law (29c): DUTIES OF OFFICERS

- The references to Executive-Manager have been changed to Executive Director as this better reflects the current position in the association.
- The duties of the Executive Director have been streamlined to incorporate the
  additional employees of the association and function of the Executive Director. This will
  also allow for potential continued growth of the association without a need to update
  the by-laws.
